REGULAR MEETING August 9, 2023

Phillips and Sons Tree Service addressed two of the trees that were of concern. The tree on Della still needs addressed. Scott Sheets will mark it and Jason will contact the tree company.

The truck has been ordered.

PUBLIC INPUT AND COMMENTS:

Bob and Jeanie Kidd was present. They will volunteer to help with our website.

A resident asked about patrol coverage. She requested more time during the day. One of the Board members will relay the message. She also informed the Board that there have been people in the Village that appear to be soliciting.
